
Biography

Native of Saint Louis, Missouri, U.S. Clark decided to join the Development business during his time at Parkway Central High School. Soon after obtaining his diploma, Clark joined the father's business, Clark Painting Company, where he served as Project Director. Clark left his father's company after gaining some experience; became a Partner at Machine Maintenance and Equipment Company (MMECO). Under Clark's stewardship, MMECO became the leading Midwest distributor for Ingersoll Rand and Gardner Denver products. At the age of 24, Clark founded Clayco, as a start-up construction company. In it's first year, the company made annual revenues of \$1 million. Clark has since expanded the business to include Forum Studio, an architecture and engineering group, Concrete Strategies, a specialty contracting firm and Clayco Realty Group which provides full-service commercial real estate development, delivery and consulting. The company posted annual revenues of over \$800 million for 2010. Clark currently serves as Chairman and CEO of Clayco Construction Company.

Interesting Facts

When Clark first started Clayco, it was in an underprivileged neighborhood. One day, Todd Weaver, an 11-year-old boy visited the office asking for a job as he needed to take care of his family, Clark told him to go to school, but come work in the afternoons, and he eventually took the boy in to live with him. Weaver became like a big brother to his own three children, graduated from college and has his own construction business, the Legacy Building Group.

During Clark's Interim Administration at the Central Institute for the Deaf, the Institute entered into a Partnership with the Washington University in St. Louis, the alma mater of Tom Cohn, who is the President of Thomas Cohn Associates. Clark serves as a Director in the Institute.

When Clark's wife died in 2010, he felt he needed to get away for a while, so he traveled around the world alone and ended up in Katmandu, Nepal. He remembers: "I hired a guide and trekked a couple hundred rugged miles with him. I wasn't in good shape, and at one point I was in such agony that I lay down. My guide said he'd leave me there if I didn't get up."

In his professional career Clark has received many awards, including: the 1992 Construction / Real Estate Award Winner Central Midwest Region by the Ernst and Young Entrepreneur of the year award, was also named Construction Man of the Year in 1997. In 2003, March of Dimes awarded him with the "Building the Community" Lifetime Achievement Award for on-going commitment to the St. Louis community. In 2007, Clark was received the What's Right with the Region Award, for Improving Racial Equality and Social Justice, given by Focus St. Luois. In 2008, Engineering News-Record voted him one of the Top 100 Green Contractors, the St. Louis Business Journal voted him for Heroes of the Planet for Sustainable Communities Winner and he won Entrepreneur of the Year by the AFL-CIO Building Trades Council of St. Louis NAACP for his Commitment to St. Louis.

In a statement about his late wife, Clark described her as a very determined person: 'Ellen was a passionate person who campaigned for the 2006 constitutional amendment protecting human embryonic stem cell research in Missouri, and last April (2009), President Barack Obama invited us to the Oval Office after he signed the legislation."

Clark suffered from Attention Deficit Disorder since his childhood, but he believed this to have been what drove him to become a builder. In an article that he authored, Clark remembers looking at the construction site outside his school and getting distracted in classes.

Clark organized an Egyptian themed party for his wife Ellen's 50th Birthday, reportedly so that Ellen was able to be carried into the party on a litter as Cleopatra and set up in a loggia where guests could meet with her. At the time she suffered from Cerebroretinal Vasculopathy (CRV), which made it difficult to walk or stand for long periods of time.

Clark met his late wife, Ellen, at Parkway East Junior High School in 1972 and married her in 1984, the same year he started Clayco. The couple was together until she died in 2010.

In 2001, Clark took a sabbatical to run the non-profit Central Institute for the Deaf in St. Louis, which his wife had attended as a child. Reportedly he was elected Interim President because the organization faced financial difficulties, and after making management changes he became Executive Director, forgoing a salary. Supposedly he was in charge of merging much of the institute with Washington University Medical Center.

Due to Clark's late wife's affliction with the Cerebroretinal Vasculopathy (CRV) disease, the couple spent money and energy trying to find a cure. Ellen, Clark's late wife, spent her last years promoting stem cell research and working for a cure for the disease, also donated her body to medical research and within minutes of her death, a Washington University School of Medicine research team, headed by Dr. John Atkinson was assembled at Barnes-Jewish Hospital. The team conducted an autopsy to determine the cause for the cell's deterioration. The quick access they were permitted to was unprecedented at the time, and the doctor said "It will provide dividends for a long time."

Modest philanthropic donor, gives primarily to Healthcare causes. Clark does not appear to have a family foundation, but has been donating privately, his late wife Ellen appears to have been the inspiration for his philanthropic gestures as she suffered from Cerebroretinal Vasculopathy, or CRV, a rare disease. Both Clark and his wife invested money and time in efforts to find a cure. Ellen even asked that her body be donated for scientific and medical research, and an autopsy was carried out within minutes of her being declared deceased. Lifetime giving is uncertain. Recipients include: The BJC Institute of Health at Washington University School of Medicine in St. Louis, where the couple donated an undisclosed amount as a naming gift to found the Ellen S. Clark Hope Plaza, Clark is also a Trustee of the University of Chicago Medical Center, and Saint Louis University; he also serves as a Director on the Board of the Central institute for the Deaf.
